Residential 25mm - 40mm	\$256.00

Hydraulic designs must be prepared and submitted to Hunter Water upon but not limited to the following circumstances; when the water meter is to be greater than or equal to 32mm, installation or alteration of a trade waste facility or dedicated fire service and large or complex installations as specified in Hunter Water's Land Development Manual. SHUTDOWN AND CONNECTION ALL GST FREE	
CONNECTION TO EXISTING WATER SYSTEM This fee applies when the developer elects to insert a tee and valve in order to connect a major development to the water supply system. This fee covers assessment of most appropriate shutdown method, shutdown and recharge mains. Additional charges may apply for water tanker cartage or for Hunter Water standby rates.	
MAJOR WORKS (VALVE SHUTDOWN)	\$747.00
MAJOR WORKS (NON-VALVE SHUTDOWN)	\$318.00
INSERTION OR REMOVAL OF TEE & VALVE This fee applies when a developer elects for Hunter Water to insert the connection to existing mains. This fee covers assessment of most appropriate shutdown method, shutdown and recharging mains. Additional charges may apply for water tanker cartage or for Hunter Water standby rates.

BACKFLOW PREVENTION DEVICE TEST This fee is charged to the owner of a property where they fail to have their backflow prevention device tested as per the Customer Contract. The fee covers administration and backflow device testing costs.	\$346.00
