



# RECYCLED WATER POLICY

## Scope

All managers and employees involved in the supply of recycled water are responsible for understanding, implementing, maintaining and continuously improving the recycled water management system in line with this policy.

## Policy Statement

Hunter Water supports and promotes the responsible use of recycled water and the application of a management approach that consistently meets the Australian Guidelines for Water Recycling, as well as recycled water user and regulatory requirements

## Application of Policy

In partnership with our stakeholders Hunter Water will:

- Ensure that protection of public and environmental health is integrated into the management of recycled water.
- Implement recycled water initiatives where environmentally, socially and economically beneficial.
- Engage appropriate scientific expertise in developing efficient recycled water schemes.
- Recognise the importance of community consultation in decision-making processes.
- Consider the needs and expectations of recycled water users, communities and other stakeholders, regulators and employees in the planning process.
- Manage recycled water quality along with the delivery chain from source to the recycled water user.
- Use a risk-based approach in which potential threats to recycled water quality are identified and controlled.
- Establish regular monitoring of control measures and recycled water quality and establish effective reporting mechanisms to provide relevant and timely information, and promote confidence in the recycled water supply and its management.
- Develop appropriate contingency planning and incident-response capability.
- Maintain communication and partnerships with all relevant agencies involved in management of water resources, including waters that can be recycled.
- Continually improve our practices by assessing performance against corporate commitments and stakeholder expectations.

Hunter Water will implement and maintain recycled water management systems consistent with the Australian Guidelines on Water Recycling to effectively manage the risks to public and environmental health.

Term	Definition
Recycled Water	Treated wastewater that can be used in industrial processes, to irrigate agriculture, urban parks and landscapes, and in the home for flushing toilets, car washing and watering gardens. It is not used for drinking water or personal use.
<a href="#"><u>Recycled Water Quality Management System</u></a>	A Recycled Water Quality Management System consists of documents, procedures and other supporting information that outlines the suppliers systems for the safe supply of recycled water.
